The undersigned is informed and believes that:

COUNT 1

On or about August 28, 2026, in the County of Santa Clara, State of California, the crime of MURDER, in violation of PENAL CODE SECTION 187(a), a Felony, was committed by ANILA BABY who did unlawfully and with malice aforethought, kill [REDACTED] a human being.

It is further alleged, pursuant to California Rules of Court section 4.421(a)(1), that the defendant, ANILA BABY, committed the offense(s) charged above in Count(s) 1 and the commission of the crime(s) involved great violence, great bodily harm, threat of great bodily harm, and other acts disclosing a high degree of cruelty, viciousness, and callousness.

It is further alleged, pursuant to California Rules of Court section 4.421(a)(2), that the defendant, ANILA BABY, committed the offense(s) charged above in Count(s) 1, and the defendant was armed with or used a weapon at the time of the commission of the crime.

It is further alleged, pursuant to California Rules of Court section 4.421(a)(8), that the defendant, ANILA BABY, committed the offense(s) charged above in Count(s) 1 and the manner in which the crime(s) was(were) carried out indicates planning, sophistication and professionalism.

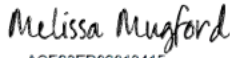
Any defendant, including a juvenile, who is convicted of and pleads guilty and no contest to any felony offense, including any attempt to commit the offense, charged in this complaint or information is required to provide buccal swab samples, right thumbprints and a full palm print impression of each hand, and any blood specimens or other biological samples required pursuant to the DNA and Forensic Identification Database and Data Bank Act of 1998 and Penal Code section 296, et seq.

Further, attached and incorporated by reference are official reports and documents of a law enforcement agency which the complainant believes establish probable cause for the pretrial restraint of defendant ANILA BABY, for the above-listed crimes.

Complainant therefore requests that the defendant(s) be dealt with according to law.
